Stand up and speak out against hatred and bigotry

Once again, our hearts break in horror at the murderous rampage and terror inflicted by a cowardly white supremist at Congregation Chabad in Poway (22 miles from San Diego). We mourn the tragic loss of life and the injury to three others, including a one-year old child and nine-year-old girl.


As the investigation unfolds, we learn that the suspect claims responsibility for setting fire to a nearby mosque, within the last month. There were seven people inside at the time of the arson and they were able to put the flames out with no one being injured.

Commit to fighting bigotry and hatred in all its many forms. Stand up and speak out in defense of our neighbors, friends, and ourselves whenever we see or hear something that inflames and promotes hate.

Make a personal pledge to Stand Up against Hate!

- Speak out when you hear someone being attacked for who they are
- Talk about how stereotypes, prejudice and discrimination hurt our society
- Ask legislators to support laws that protect and advance civil rights
- Never allow a bigoted slur to go unchallenged
- Denounce online hate and report conduct that violates terms of service
- Unite with diverse communities & educate ourselves on how to be an effective ally
- Protect our neighbors by building welcoming communities



Ask members of Congress to move against gun violence

Please consider contacting our members of Congress and asking them to work actively to pass common-sense legislation to reduce gun violence. Gun violence prevention experts have recommended several policy approaches:

- Congress can close legal loopholes that allow people to buy guns without background checks from private sellers, websites, or gun shows. A move that over 80% of gun owners support.
- Congress can institute universal background checks for both gun and ammo purchasers and require gun licenses, all measures supported by most Americans.
- Congress can adequately fund community-based interventions such as the nearly 20-year-old Ceasefire program, an underfunded effort that has helped to reduce gun violence in cities through education and public health crisis strategies.
- Congress can reinstate the assault weapons ban that expired in 2004, or pass new legislation banning the purchase of high-capacity magazines and military-style assault weapons.

Two Leavenworth Public Hearings – Appeal of the Adventure Park SEPA determination followed by the Conditional Use Permit and Variance Hearing for the Adventure Park

Tuesday, April 30, at 8:00 AM at Festhalle, 1001 Front Street, Leavenworth, WA 98826

The following information is from the official City of Leavenworth Notice of Public Hearings (link to notice):

"Hearings: The first hearing will address a SEPA Appeal on the Adventure Park Mitigated Determination of Non-significance (MDNS) brought by the Friends of Leavenworth, contact Alan Hunt and Kirvil Skinnarland. During the appeal hearing, the Hearing Examiner will take public testimony on the underlying land use applications for the Adventure Park, files CUP 2018-04 and VAR 2018-02. Each person testifying will have 3 minutes to speak. After the Appeal Hearing the Hearing Examiner will open the Land Use Hearing, for the Adventure Park, files CUP 2018-04 and VAR 2018-02, which will include presentations by the City Staff, the applicant, and the appellants."

"The public is encouraged to attend and provide comment and/or provide comment to Development Services prior to the hearing. Materials, including the Staff Report, may be viewed, during normal business hours at City Hall or online at http://cityofleavenworth.com/city-government/developmentservices-department/land-use-applications/. Questions may be directed to Development Services."

If you have ever considered serving your community in this capacity, now is the time to make the decision to jump into the race. It is a difficult, sometimes entirely thankless responsibility, but also a direct way to make a difference. In a smaller community, our neighbors and friends sit in these positions, often dealing with the most difficult challenges of balancing laws and regulations, with economic and community realities. **We encourage**



you to run for office and we encourage you to support and campaign for those in office already doing a great job.

Filing deadlines

In-Person:

Candidate filing begins in-person, or by messenger, Monday, May 13th at **9:00 a.m.** and closes Friday, May 17th at **5:00 p.m.** in the Chelan County Auditor's Office, located in the Chelan County Courthouse, 350 Orondo Ave, Level 3, Wenatchee, WA.

Online:

Online candidate filing begins Monday, May 13th at 9:00 a.m. and closes May 17th at 4:00 p.m.

By Mail (delivery through the US Postal Service):

April 29, 2019 is the first day the Elections Office may receive candidate declarations by mail.

- Declarations submitted electronically (fax or email) are not considered by mail.
- We cannot accept declaration forms prior to April 29, 2019.
- All declarations received by mail are held and will not be processed or publicized until the first day of the filing period (May 13, 2019).
- The Elections Office must receive declaration forms no later than the end of the last day of candidate filing (May 17, 2019). Delivery to another department in the county or state does not qualify as valid delivery.

Electronic (Fax or Email):

With the exception of filing fee petitioners, a candidate may submit declarations of candidacy electronically during the filing period (May13th - May17th).

- The same deadlines and requirements apply as for in-person filing.
- If payment if a fee is required, electronic filing is not complete until receipt of the fee.
